"This is a follow up to the e-mail sent earlier today regarding the **Certificate Reinstatement for Keithies Industrial Home Improvement Inc., d/b/a Keithies Industrial Roofing**".

The Construction Trades Qualifying Board on May 25th, 2011 ordered the suspension lifted of the Certificate of Competency with the conditions the Respondent must register with the State within 60 days of the hearing and, upon registration, the Respondent must adhere to the Amended Order issued on May 26, 2010 (Attached).

Note: Without the state registration, permits cannot be issued to Mr. Wilson. The Reinstatement of the certificate alone does not grant that privilege.
