All privately funded construction with a total value over \$200,000 must comply with Sections 10-33.02 and 2-10.4.01 of the Code of Miami Dade County (the "Code"), which govern the County's Community Small Business Enterprise ("CSBE") and Community Business Enterprise ("CBE") programs. The Developer shall submit or cause to be submitted the Design and Construction Packages, to the Small Business Development Division of The Regulatory and Economic Resources Department ("SBD/RERD") prior to advertisement, for review and determination of appropriate small business program measures, and the application of same. All packages must be advertised and awarded with the applicable small business measures in accordance with the requirements of the above mentioned Code."

There are two (2) SBE firms certified in the required Commodity Codes.

Commodity Code: 40502-Alternative Fuels (Not Otherwise Classified); 40513-Gas, Natural (Incl. Compressed Natural Gas (Cng)); 96141-Global Positioning Systems Surveying Services
